**WHEREAS** the author of the Trust is desirous of settling on trust a sum of Rs. 45001/- (Rupees forty five Thousand One Only) for the public educational charitable purposes and whereas the parties of the second part have hereby consented to act as Trustees of the Trust.

**AND WHEREAS** the author of the trust has settled the above referred sum of Rs. 45001/- upon trust by transferring the same finally to the trustees. The trustees will keep this amount of Rs. 45001/- and any addition, accretion, income or accumulation which may accrue from this sum or which may be received by them for trust in trust and these shall constitute the trust fund which will be utilized for achieving the aims and objectives of the trust mentioned hereinafter.

**AND WHEREAS** the author of the trust is desirous of alleviating the suffering attaining upliftment of the common masses in the society, he has decided to create a public charitable welfare trust and has on this 14 th day of Dec 2013 set apart the sum of Rs. 45001/- to begin with for extending humanitarian services in all their form and promising Indian citizens who are in dire need of economics, medical and moral upliftment.

In pursuance of the aforesaid desire and for carrying out such desire into effect he has settled of Rs. 45001/- on the trustees named mentioned above to hold the same upon trust and to utilize the trust fund including all accumulation and accretion thereto and purpose hereinafter mentioned.

7. **Management of Trust:** The General Management of the Trust for the purpose of managing the affairs and properties and carrying out the objects of the trust aforesaid shall be vested in the Board of Trustees. The Board of Trustees shall have one chairman who shall be the principal executive officer of the Trust. The First chairman of the Trust shall be for life. During his lifetime he may nominate one of the trustees as his successor in office. The Trustee so nominated shall enter into the office of the chairman after the lifetime of the present chairman/secretary **RIMANSHU BHUSHAN MISHRA**. If the present chairman fails to nominate his successor during his life time in that event after his lifetime the remaining trustees shall elect one amongst themselves as the chairman of the Board of Trustees and without prejudice to the generality of the objects and powers above mentioned they shall have to do all or any of the following: -

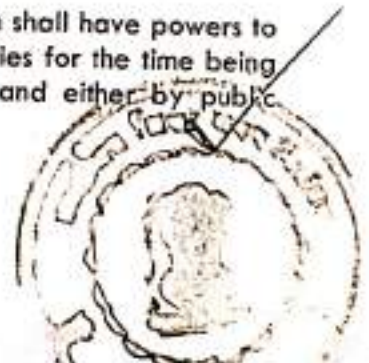
- 1) To enter into contracts and borrow money from Banks, Institutions or individuals for the purpose of the Trust and management of its properties and assets.
- 2) To appoint consultants for specific purposes on such terms and conditions as they may deem fit.
- 3) To enter into agreements with organizations and individuals for execution of any projects that may be undertaken or taken over by the Trust from time to time.
- 4) To make rules and regulation from time to time for the management and conduct of the affairs of the Trust and its properties and assets.
- 5) The number of Trustees shall not be less than three and not more than seven. The Trustees shall be trustees not for their life time but any trustee may resign by giving notice in writing to his co-trustees and shall also cease to be a Trustee if requested in writing by three fourth of the remaining Trustees or the number nearest thereto if such trustee's activities found to be in contradiction of the purposes of the trust or he is found to be a guilty person in the eye of law. Appointment of Trustees, either to fill up a vacancy or as additional Trustee, shall be with the discretion of the founder of the trust.

**Power of trustees:** The Trustees will also have the following powers by passing resolution in the general body meeting by majority of votes as follows-

- 1) To apply the whole or part of the income or accumulation thereof or whole or part of the corpus of the Trust properties for one or more of the objectives of the Trust as the Trustees may from time to time determine To amalgamate the Trust with any other Trust or society for wholly public charitable purposes.
- 2) To convert and get in the Trust properties and or to vary the investments for the time being.
- 3) To invest and keep invested the trust properties in the purchase of immovable properties or in other assets specified in section 11(5) of the Income Tax Act, 1961 and to alter vary and transpose such investment from time to time as the Trustees shall in their absolute discretion, think fit. In any case the funds of the Trust shall not be invested in any of the manner, which is not permissible by relevant provisions of Income Tax Act, 1961 applicable at any given time.
- 4) The founder, secretary and treasure with majority of the opinion shall have powers to sell or assign any movable and immovable property or properties for the time being forming part of the Trust fund either together or in parcels and either by public

auction or private contract and either with or without any special or other stipulation as to title, evidence of commencement of title or otherwise and to buy in or rescind or vary any contract for sell or to re-sell without being made answerable for the loss occasioned thereby and for the purposes aforesaid or any of them to execute and do all such assurances acts, deeds and things as they shall think fit and out of the moneys which shall arise from any such sale for the interest and of the Trust or otherwise in or about the execution of any of the Trusts or powers of these presents and shall stand possessed of the residue of the said moneys and also of the rents and profits of the said premises or of the unsold part thereof for the time being upon such Trust and subject to such powers provisions, agreements and declaration as are herein declared, provided, always that the Trustees shall manage may immovable property or properties for time being forming part of the Trust fund in such manner as they shall manage may immovable property or properties for time being forming part of the trust fund in such manner as they shall think fit with full powers to make improvements repairs or alternations of any description and to make or incur any outlay for any such purpose or for the Insurance or otherwise for the protection or benefit of the said premises and to grant or renew leases of any description and upon any terms of the said premises or any of them or any part or parts thereof and to enter into any agreement or agreements or any descriptions for or in relation to the tenancy or occupation of the said premises or any of them or any part or parts thereof and to accept, surrenders of leases and agreements either in contemplation of a renewed lease of tenancy or occupation under the same respectively and to make any allowance to or agreements with tenants or occupiers or intending tenants or occupiers of the said premises and it shall be in the discretion of the trustees, either to procure or to compound or submit to arbitration or settle in any other manner and if through fit altogether give up and release any remedies or demands against tenants or occupiers or any other person or persons, whomsoever in relation to the premises.

- 5) To invest, dispose off, transfer and otherwise deal with the subject matter of the trust in such manner, as the trust deem fit and proper to do carrying out the objects of the Trust.
- 6) To open accounts with any Bank or post office for the purpose of keeping the moneys of Trust, to operate such accounts including over draft accounts and to give instructions to the Bank or post office and to provide for opening and operation of such accounts by the secretary and one of the trustee jointly. However the secretary may Change the signing trustee of the Bank account from time to time as he think fit.
- 7) To appoint, constitute attorney or agents, committee or sub-committee and to delegate to such attorney or agents all or any of the powers vested in them under these presents from time to time and remove such attorneys or agents and to appoint other or others in their place.
- 8) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the trust and for the management of the affairs thereof and of running any institution in furtherance of the object of the Trust and otherwise for giving effect to the objects of the Trust.
- 9) To set apart the whole or part of the income or the corpus or part thereof or any of the objects of the Trust.
- 10) It shall be lawful for the Trustees to settle and determine all matter of interpretations of these presents as well as all matter of difficulty, or doubt or dispute and all questions arising in the course of or incidental to the administration management and execution of the trust and power under these presents and any such settlement or

determination although the question involved any not have been actually raised shall be valid binding and conclusive and shall not be rejected to or re-opened any ground whatsoever.

- 11) To settle compromise or compound out of court all suits actions and other proceedings and to settle all differences and demands and to refer any or all such suits actions or other proceedings differences or demands to arbitration and to adjust and settle all accounts relating to the trust fund and execute release and to all things relating thereto as fully as if they were absolutely entitled to the trust fund and without being answerable for the loss occasioned thereby.
- 12) The secretary/founder shall be entitled from time to time the appoint with or without remuneration and on such terms and conditions as they may think proper persons or agents and to appoint committees as they may think necessary to function under the authority and control of the trustees for carrying out the trust of these presents or the management thereof and may within the limits of their own powers invest them with all such powers including power to incur all such expenditure as may be necessary for carrying out the objects of the trust.

#### 8. Duties of the trustees:

- 1) The trustees shall be chargeable only for such moneys, stocks shares and funds that shall actually come into their hands and shall act be answerable or accountable for neglect default acts of commission of the other trustees nor of bankers or other person with whom the trust properties or any securities may have been deposited or handed over unless caused by their willful neglect or default.
- 2) All the trustees shall be bound to maintain and defend all such suits and to take such other steps as may be reasonably requisite for the conservation of the trust property and the assertion or protection of the life.

9. **Rules of the Trust:** The Trustees may from time to time frame rules for the conduct of the affairs of the trust and regulating the meeting of the trust in the absence of the regulations.

- 1) All matters will be decided by majority and three trustees shall form a quorum for meeting of trustees provided however of the number of trustees fall below three of them for the purpose of appointing a trustee two will be a quorum.
- 2) Resolution passed by founder/secretary without any meeting of the trustees and thereof evidence in writing under the hands of three fourth of the trustees or the number nearest thereto shall be as valid and effectual as resolution duly passed at the meeting of the trustee.

10. **Accounts and audit:** The accounts of the trust shall be closed on 31<sup>st</sup> March each year and after the closing the statement of accounts in such form as the Board of trustees may decide or determine will be prepared and thereafter the same shall be presented to the auditors for report as the Board of trustees may appoint from year to years and their remuneration shall be decided accordingly at the meeting.

**11. Meeting:**

- 1) The meeting of the Board of trustees shall be held at least three times in a year. The meeting may be held at any place within the territory of India at the discretion of the chairman of the Board of trustees.
- 2) A minute book shall be kept by the chairman wherein entry of all the proceedings of the meeting of the board of trustees shall be made which shall be signed by the chairman of the meeting either at the conclusion thereof or at the next meeting.
- 3) All the powers and provisions hereof provided in the trust deed shall be restriction and limitations herein contained.

**12. Allowance to trustee and office bearers:** If at any time any trustee acts as whole time office bearer of the trust or renders any special service the trustees may at their direction pay such remuneration or allowance to him as they may think proper.

**13. Board to reimburse:** The trustees of THESE PRESENTS are entitled to be reimbursed and also to pay and discharge out of the trust fund, all expenses incurred by them or on their behalf in or about the execution of the trusts and power of THESE PRESENTS.

**14. Amendment:** The amendment in this trust deed shall only be effected if the same is approved by three-fourths majority of the trustees.

We, the author of the trust and Trustee do hereby declare that we have settled this trust and executed this trust deed with own will and without any coercion with sound minds and full senses. We have handed over the trust fund to the trustees mentioned herein above for the purposes of the trust.




